OFFICIAL RULES**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT IMPROVE THE CHANCES OF WINNING.**

The “Cook Safe & Win” Giveaway (the “Sweepstakes”) is intended for legal residents of the United States of America (“USA”), and Canada, and shall only be construed and evaluated according to the laws of the USA and Canada.

**Sponsor/Administrator:** The Sweepstakes is sponsored by Pioneering Technology Corp., 2400 Skymark Ave Unit #7, Mississauga, ON L4W 5K5, Canada (“Sponsor”) and administered by Mindshape Creative Brand Marketing, 1384 Cornwall Rd, Oakville, ON L6J 7W5, Canada (the “Administrator”).

**ELIGIBILITY:** The Sweepstakes is open to legal residents of the United States (including the District of Columbia; excluding Rhode Island) and Canada (excluding the province of Quebec) who are at least eighteen (18) years of age or the age of majority, whichever is older, in their respective state or province of permanent residence as of November 15, 2018 (the “Entrants”). “Cooking Fire Safety Quiz” (the “**Quiz**”). All of the aforementioned information fields are required. Incomplete information may result in disqualification of entry.

**Bonus Grand Prize Entries:** Entrant will receive one (1) additional grand prize entry per referral upon the successful Sweepstakes entry of each of the referred friends. Each Entrant will be eligible to receive a maximum of six (6) entries throughout the Sweepstakes Period.

By entering, Entrants warrant and represent that they agree to be bound by these Official Rules and the decisions of the Sponsor and Administrator, which shall be final in all respects relating to this Sweepstakes. Proof of submission of an entry is not considered proof of delivery to or receipt by Sponsor. Each potential First Prize Winner will be notified by phone, email, mail, or other home delivery service of Sponsor's choice.

The potential Grand Prize Winner will be selected, from among all eligible entries received, in one (1) random drawing by the Administrator, an independent judging organization, whose decisions are final in all matters relating to this Sweepstakes. The Grand Prize drawing will be conducted on or about January 2, 2019. Odds of winning the Grand Prize will depend on the total number of eligible entries received during the

Sweepstakes Period. The potential Grand Prize Winner will be notified by phone, email, mail, or other home delivery service of Sponsor's choice.

**DISPUTES:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants, Administrator, and Sponsor in connection with the Sweepstakes shall be governed by and construed in accordance with the laws of the province of Ontario, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's or jurisdiction's laws. The waiver by Sponsor or Administrator of any provision of these Official Rules shall not constitute a waiver of any other provision herein.
